

Loves Me Some Barn

Usually I'm grammatically prim and proper in this column but when it comes to the Trolley Barn, I get all giddy and find myself lapsing into colloquial expressions.

I must confess that, since I assumed office in June 2014, I pay a little more attention to the place

as I arrive early on the 3rd Wednesday of the month, unlock it, turn the lights on, and get the heating (or cooling) in gear. I look around at the expansive space, unobstructed by columns, and the classic architecture that lends both form and function.

As you are probably aware by now, that grand old dame that serves as our monthly meeting hall, not to mention our party venue and archives, is being sold by its current owner, the City of Atlanta.

Thanks to meetings held by Inman Parkers with the Mayor, this will be accomplished via the City's Invest Atlanta affiliate. The City Ordinance introduced by our Councilperson, Kwanza Hall, and passed by City Council, stressed the importance of the new owner preserving the historic structure for use as a venue open to the public. All of this is promising in terms of Inman Park's desire that the neighbor-led Atlanta Edgewood Street Railway Company (AESRC) be the successful purchaser.



But the City cannot simply hand it the keys. Instead, through Invest Atlanta, it must publicly develop a Request for Proposal (RFP) and advertise it, which they have done. The RFP was released in early September and was due on September 30th, 2015. The AESRC submitted what appears to be a very competitive proposal.

We, the Inman Park neighbors, must now think positive thoughts in the hopes that our neighbors at AESRC have submitted what will turn out to be the winning proposal. It included what is considered a fair and reasonable financial offer, an offer that could only have been made due to the success of the fund-raising carried out earlier this year.

IPNA Business Meeting Minutes - September 16, 2015

President Dennis Mobley called the meeting to order at 7:30 p.m.

Newcomers were Paul Calvert, Greg Best, Richard Tang, and Dan & Sherry Popovic.

Minutes: A motion was made, seconded, and carried to approve last month's Minutes.

Announcements: Oreon Mann, IP Book Club, announced the next meeting will be on Sept. 29 at 7 p.m. at the home of Cathy Cook and Jim McKinney, 337 Drexel in Decatur, to discuss The Rosie Project by Graeme Simsion. Pat Westrick announced the next Porch Party at 1107 Austin, hosted by Carol and Ben Mitchell, on Sept. 25 at 7:30 p.m. Bring a dish to share and a beverage. Danny Feig-Sanoval announced an Oct. 22 meeting at Manuel's Tavern at 7 P.M. concerning building a bridge over Moreland Ave at Freedom Parkway. Cameron McCaa announced the upcoming Springdale Park cleanup. Jamie Allen announced the IP Squirrel Census for the month of Oct., with volunteers counting squirrels every day. Dan and Sherry Popovic announced they are seeking volunteers for Innovation in Action, which teaches entrepreneurial skills to students.

Elected Officials' Reports: David Dryer and Josh Noblitt spoke about their aspirations for the District 59 seat. Jav Tribby, Chief of Staff for Kwanzaa Hall, announced that 1) the new Trees Atlanta Treehouse at Stoveworks offers educational programming; 2) he and the Springvale Park team will meet with city officials regarding renovations and grants; 3) Streets Alive is Sept. 27, 2:00-6:00 p.m; 4) Lifelong IP met with city officials regarding a design prospective for aging in place. IPNA will review the resulting proposal. Projected launch is 2016; 5) Kwanzaa Hall introduced legislation for a tiny house feasibility study; 6) Hall also submitted the KLENH study; there has been no follow-up. Some neighborhoods' proposals aren't nearly as detailed, so their descriptions are being refined. The department of public works will report back to IPNA within two months. Discussion ensued about how to expedite

the projects in the KLENH study. Tribby said everything in the KLENH study will be funded. Danny Feig-Sanoval will follow up with Tribby about using existing impact fees to fund the most needed projects sooner. Residents can also present needs at NPU meetings to call the attention of public officials to issues.

Keith Lamar, Zone 6 community prosecutor, reported that: 1) Buckhead is having an issue with auto break-ins; 2) his office is working on initiatives including an auto theft task force to lower our insurance rates and stop breakins by deploying more officers; 3) the alleged Vortex homicide assailants had an arraignment, and the trial date will be announced in the next couple of weeks; 4) Terrell Alexander, auto break-in repeat offender, is coming up for trial, and we will get a court watch notice for that trial as well as the Vortex trial.

Police Officers' Reports: Officer Thomas Soukup reported that 1) Officer Hays, our newest IPSP member, started his career in Zone 6 and has a vested interest; 2) the recent shootings near Grady were not related to any school event; 3) violent crime is down throughout the city and especially in Zone 6; property crimes are high; 4) there has been a rash of apartment burglaries; don't let people piggyback through the door. Call 911 first and then IPSP.

IPNA Officer Reports: Dennis Mobley, President, announced 1) we are not discontinuing the directory but making it available online and likely in a different printed format, possibly a print-on-demand version from the Inman Park Business Center; 2) the Bylaws Committee met today and will meet again before next month's IPNA meeting at 6:30 p.m. Email Andy Coffman with questions.

Brian Roof, V.P. Historic Preservation: no report

Barbara Leach, Treasurer: Barbara announced the proposed budget for 2016. We are setting aside \$35,000 for the Trolley Barn purchase. Danny Feig-Sandoval asked that \$2,000 of his proposed 2016 transportation money be given to PEDS for crosswalks and

crossing signs. The Education Committee requested additional funds. Discussion ensued. Dennis suggested the committee meet with the board at the October meeting.

Public Safety Update

Staying Safe While Walking or Driving: Don't be a victim!

In my continuing series, I interviewed another of our Inman Park Security Patrol Officers, Investigator Canup. For his APD job, Inv. Canup is a detective with our Zone 6 (VaHi, Poncey Hi, O4W, Candler Park, Inman Park, Edgewood, Kirkwood, East Lake, Grant Park, and East Atlanta), Criminal Investigations Division. When he is not patrolling Inman Parking in our IP Security Patrol car, his job is to investigate robberies involving a weapon or threat of force in Zone 6, whether it be a pedestrian mugging, car jacking, home invasion or strong arm robbery (no weapon but threat of violence).

Q. What types of robberies are you seeing mostly these days?

Inv. Canup: Item snatches that turn into strong arm robberies when the victim fights to keep his valuables. Pedestrian muggings on foot or jumping out of a car and producing a weapon. Car jackings where someone approaches a vehicle at a light or parked/occupied and produces a weapon.

Q. What should pedestrians do to keep safe while they are walking around our neighborhoods?

Inv. Canup: What you have to know about muggings is they are almost exclusively are more about 'street cred' and kids living the 'street life' then about the stuff they get. These guys, and we have seen an uptick in females, are predators looking for opportunity and weakness. They typically look for people alone, people intoxicated leaving a bar or restaurant, females (alone or in groups), or people distracted by their phone.

Q. What can you do if you feel uneasy about a situation?

Inv. Canup: Trust your instincts. If someone gives you a bad feeling, carry yourself tall and look them directly in the eye. It shows them 'they see me and they can ID me' and it also shows them that you are aware of your surroundings. The street has taught these predators it might be better to look for an easier target.

Q. What do you do if you are held up?

Inv. Canup: If a gun is produced, most people look at the gun. Focus on the face. Comply with their demands, give up your valuables, break your tunnel vision on the gun and concentrate on being a good witness.

Q. Do you recommend defending yourself with a weapon?

Inv. Canup: It's virtually impossible to out draw a gun in your face. However, I am big proponent of peoples right to defend themselves, if they have the means, training and opportunity to do so. If you have a gun, train very well on it. Take classes on how to react in a dangerous situation. Practice pulling the gun in and out of your holster or purse. Do the same with MACE or a knife. Know how to use it. Practice pulling it out of your purse or pocket. Practice pulling it out several times right before you head out for the night.

Q. Where have you seen these situations go bad?

Inv. Canup: These situations end up badly when the victim chooses to fight back without the proper means or without relevant training. A while back we had a very young group of muggers committing crimes; one as young as 12. So when the 12 year old walked up and pointed a gun at people, they tended to not take them seriously. So the 12 year old had to prove himself by firing shots in the air. They escalated in violence each time and, eventually, it ended in them shooting someone for fighting with them when they went to rob them.

Q. What can drivers do to avoid being a car jacking victim?

Inv. Canup: When you approach an intersection, ALWAYS leave space between you and the car in front of you (or obstruction) to pull out and away if someone approaches your car. Again, use your instincts here. Look for people staring at you from the side of the road. Keep your doors locked while inside. Don't hesitate to roll your window up on someone approaching. They may be looking for quick access to your car or even looking to snatch your purse or phone. Be weary of anyone approaching your car and don't be afraid to pull off if you feel threatened. Be aware of your surroundings and not on your phone.

Q. What else can you add to avoid being a victim in general?

Inv. Canup: Be prepared. Have a plan. It's a lot about your attitude. Be confident and aware. Criminals look for the easiest opportunity but you can be a target for robbery even if all you have on you are your keys. The act of robbery is more about the violence than about the stuff they get from you. It can happen anywhere and Inman Park is a target-rich environment with all the walkers, restaurants and people coming and going.

Q. What can we do as a neighborhood?

Inv. Canup: Be aware. One of the biggest deterrents is a neighborhood that is aware and defended with a sense of community of people looking out for each other. Share information. Continue to support the patrol. Be sure to go to court with many neighbors when violence happens and they are caught. Their buddies see that and your neighborhood will get the reputation of being tough and caring about what happens so they may look for easier targets.



2015-2016 IPNA Budget Overview Fiscal Year 11/1/2015 to 10/31/2016

INCOME:

Despite a rather gloomy Festival Saturday, this year's event resulted in a very healthy contribution (\$185,000) of funds received from our Festival Treasurer at the August IPNA meeting. The \$181,250 of Festival Revenue in the proposed budget reflects the Board's recommendation for FY16 spending based on the cash we have in the bank plus a conservative projection of Festival 2016 revenue. As has become our practice, the proposed Festival Revenue is based largely on actual results from a Festival already concluded.

Security Patrol Memberships/Fundraising is running slightly ahead of the FY15 budgeted level of \$110,000 so we've increased the FY16 projection to \$120,000 which we think is a realistic goal given the fundraising and membership drives planned for this Fall. IPNA Membership Dues and sales of Flags and Banners is running within a few hundred dollars of previous budget estimates. Proposed budget revenue of \$301,775 IS \$27,225 greater than last year's budget.

EXPENSES:

Proposed Budget Expenses of \$336,775 are based on spending the \$35,000 surplus we expect from the current budget year. The projected surplus assumes that the Trolley barn purchase will not close by October 31 and that we will essentially carry those funds forward to contribute to a Trolley Barn purchase in FY16. Without the surplus, spending will increase only by the \$27,225 in increased income.

Major expense categories are shown below, comparing proposed expenses, previous budgeted expenses, and variances.

Drivers of year over year variances in proposed spending are as follows:

The tragic Vortex shootings, a rash of car break-ins, and alltoo-frequent armed robberies have compelled us to gear up for increased Inman Park Security Patrol coverage. An increase of \$23,000 in Public Safety is proposed in this regard.

The IPNA Board's decision to directly hire Atlanta-based MemberClicks® to improve its website and database infrastructure, without a vendor serving as "middle man", will enable us to reduce funds budgeted for these desired improvements. Simultaneously, support for the Education Committee (\$15,000) is now categorized under Communications per IPNA By-Laws. The amount was increased by \$5,000 based on feedback received at the September IPNA meeting. The net result is an increase of \$3,500 in Communications.

During the past year, Atlanta voters approved a \$250 million infrastructure bond. Each member of City Council was given a couple of million dollars to allocate to neighborhood-based improvements in Council-approved master plans. Several high-priority intersection improvements from our Krog-Lake-Elizabeth-North-Highland ("KLENH") traffic study were proposed to Councilman Kwanza Hall. We are hopeful that funding including engineering studies will be forthcoming via this process. It should be noted that Councilman Hall is also attempting to find City funds to finance a master land use plan that anticipates development supporting "life-long" living in Inman Park. Therefore, the 2015-2016 budget proposes only a \$3,000 "placeholder" amount for engineering or consultant studies. The net result is a decrease of \$12,000 in planning resources.

Beautification efforts are slated for a significant increase, including a resumption of significant subsidies for sidewalk repairs. Other beautification activities are budgeted at somewhat increased levels. The net result is an increase of \$24,500 in beautification.

Under the Social category, an increase of \$800 is being proposed mainly to bolster the amount available for the annual Holiday Party, in the hopes that our new membership structure and web infrastructure improvements will lead to increased IPNA membership in time for the Party.

The biggest change under the Grants category is the anticipated \$30,000 IPNA contribution to the purchase of the Trolley Barn, using the bulk of the current fiscal year's anticipated \$35,000 surplus. Also significant is the transfer of \$15,000 for the Education Committee to the Communications category. In other respects, Grants are somewhat below last year's level that included a onetime contribution of \$5,000 in support of Dad's Garage's efforts to finance their new home in the nearby Old Fourth Ward. The Board is proposing to set aside \$3,500 to accommodate any future small grant requests. Also, Transportation Committee chair Danny Feig-Sandoval requested the transfer of \$2,000 from Traffic Calming to a grant to PEDS. The sum total of these changes is an increase of \$18,000.

Proposed budget expenditures of \$336,775 are \$62,225 greater than last year's budget estimate. This is made possible by virtue of increased Festival and Security Patrol revenue AND the current fiscal year's anticipated \$35,000 surplus which was engineered solely for the purpose of supporting the Trolley Barn purchase.

A detailed line-item tally of year-to-date (YTD) actuals for the seven-month period from 11/1/2014 to 7/31/2015 is attached. It includes a projection of annual income and expenses for the current budget year as well as a comparison of the previous and proposed budgets. M

Who's there? ...Beverly Gibson moved into the "Peach House" on Spruce Street in 1995. It was one of five Victorians on the market at the time. The house needed a lot of updates, but its craftsmanship, wood floors, and circular porch caught Beverly's eye. She had already fallen in love with Inman Park because as she said, "It's a little piece of Berkeley and Cambridge in Atlanta." She likes the community's live-and-let-live mentality and the diversity of people. She considers herself an Inman Parker first, an Atlantan second.



In addition to working at a software company, Beverly started the Peach House Bed and Breakfast in 2004. "One of the best things about a B&B is hosting people from all over the world," she said. "I didn't have to travel, because everybody came to me," until an afternoon in 2012. She was picking her daughter up from the hair salon when she got a call from her neighbor. "Is everybody okay?" he said. "It's our tree and I feel really badly." Beverly drove up to find her circular porch decimated by a fallen tree from her neighbor's yard. Not only was her porch in pieces, her gazebo was gone and the house's foundation even shifted. "It was unbelievable," she said.

Life for Beverly is "before the tree and after the tree." Reconstruction lasted eight months and she is still addressing a rogue leak in the porch ceiling three years later, but her outlook is positive. "Before the tree we didn't have working fireplaces," she said. "Now, they go all the way up, and we actually found two more in the process." Beverly salvaged beadboard planks from the original porch for her central hallway. Like works of modern art, the oiled planks run from the wainscoting to the ceiling high above. They are a beautiful reminder of an ugly event.




Candler Park Conservancy Hosts Public Input Meeting

Notes from the September 24, 2015 meeting:

PRESENTATIONS:

Police Department: Capt. Ben McGee reported that car break-ins are a continuing problem; laptops, phones and other electronics are the usual target. He encouraged neighbors to get involved in CourtWatch to reduce recidivism.

Fire Department: Battalion Chief James Peel suggested checking chimneys to be sure they are clear of bird nests, etc. before using fireplaces.

Memorial Drive Corridor Project: Greg Giuffrida introduced himself as project representative, a position funded by Central Atlanta Progress to work on implementation of the vision outlined in the Imagine Memorial planning process.

Candler Park Conservancy: Randy Pimsler announced the recent formation of this new non-profit group, whose focus is on stewardship of the main park area. Interested neighbors are encouraged to attend a public meeting on Sat. Oct. 24 (9-11 a.m.) at the First Existentialist Congregation, 470 Candler Park Drive NE.

SPECIAL EVENTS & OUTDOOR EVENTS:

Krog Masquerade (Krog Tunnel, Cabbagetown, Inman Park), October 17, 2015. Applicant did not attend, but sent a representative, Barbara Callahan. Representative had no substantive information to address questions from the public and NPU-N Board regarding public safety, pedestrian access and event details. NPU-N Board voted unanimously to not support based on effective non-attendance of applicant.

LICENSE REVIEW BOARD:

Gregory Best (Ticonderoga Club, Restaurant, 99 Krog St, Suite W, Inman Park); New Business request for liquor license (new location). Applicant met with IPNA and received support. NPU-N Board voted unanimously to support.

Maria Gallardo (El Bandido, Restaurant, 1083 Euclid Ave, Inman Park/L5P); New Business request for liquor license (new location). Applicant met with IPNA and received support. NPU-N Board voted unanimously to support.

Richard Tang (Niku Korean BBQ, aka Char Korean BBQ, 280 Elizabeth St, Suite S, Inman Park); New Business request for liquor license (new location). Applicant met with IPNA and received support. NPU-N Board voted unanimously to support.

BOARD OF ZONING ADJUSTMENT: 1032 Manigault St SE (V-15-206,

Reynoldstown); seeking a variance to reduce the front yard setback from 30ft to 18.9ft, to reduce the west side yard setback from 7ft to 6.9ft and to reduce the east side yard setback from 7ft to 4.3ft, to allow for a 2nd story and rear addition to an existing single family dwelling. Applicant also seeks a variance to exceed the maximum lot coverage from 55% to 58.8% (current lot coverage). RCIL voted to support the application. NPU-N Board voted unanimously to support with like condition (1 member recused).

340 Brooks Ave NE (V-15-215, Candler Park); seeking variance to reduce the required front yard setback from 30ft to 25.9ft. and to reduce the required north side yard from 7ft to 2.4ft. 2131 Palifox Dr NE (V-15-217, Lake Claire); seeking variance to reduce the required south side yard setback from 7ft to 3ft to construct a deck and sunroom addition. LCN voted to support the application. NPU-N Board voted unanimously to support the application.

299 Moreland Ave NE (V-15-222, Candler Park/L5P); seeking a special exception to reduce the number of required off-street parking spaces from 54 spaces to 24 spaces to allow the conversion of retail to restaurant. Deferred to next month at the start of the meeting per applicant request.

506 Harold Ave NE (V-15-227, Candler Park); seeking variance to reduce the required north side yard setback from 7ft to 0ft to place a 37 inch platform and 42 inch air conditioning condenser unit in the required side yard whereas otherwise restricted. CPNO voted to support the application. NPU-N Board voted unanimously to support the application per site plan filed with City on 8/19/15.

ZONING REVIEW BOARD: Druid Hill Landmark District Regulations
